Superscript note explanations:

- 1 Legal Research & Writing and Introduction to Law enroll 5 separate times per year and run for 10 weeks, with the Nov. session running 5 weeks.
- 2 Law Study & Exams - hybrid schedule, begins 5 weeks into the semester and continues into the next semester for 5 weeks.
- 3 Adv. Legal Research is limited to 14 students with priority given to 3rd- and 4th-year students and meets for 10 sessions during the semester.
- 4 Disability Law Clinic is limited to 6 students. (Option to take for 1 or 2 units also.)
- 5 SHAC is limited to 8 students. (First three training class sessions meet 6:00 – 9:00 P.M.)
- 6 Immigration Law Clinic is limited to 15 students. Training classes meet on campus, the rest of the sessions are generally held at the Professor's office.
- 7 Elder Law and Small Claims Advisory Clinics are limited to 8 students. (Small Claims option to take for 1 or 2 units also)
- 8 Clinical Education is available to 3rd- and 4th-year students only. See Catalog or separate package for further details.
- 9 Community Property is limited to 25 students and requires completion of 2nd year classes.
- 10 Criminal Procedure class limited to 30 students, priority given to 3rd- and 4th-year students.
- 11 Moot Court limited to 16 students, priority given to 3rd- and 4th-year students.

\* Denotes all non-severable two semester courses. Both semesters must be successfully completed to receive final A/B Course grade.

\*\* Electives - 13 elective units are required for graduation. Elective courses can be taken during the summer, fall or spring semesters, as student schedules permit. There are more electives offered than shown on this schedule; offerings change from semester to semester.
