2 Adv. Legal Research is limited to 14 students with priority given to 3rd- and 4th-year students and meets for 10 sessions.

3 Law Study & Exams - continuing session restarts 5/4/17 and ends 6/1/17

4 Moot Court limited to 16 students, priority given to 3rd- and 4th-year students.

5 Disability Law Clinic is limited to 6 students. (Option to take for 1 or 2 units also.)

6 SHAC is limited to 8 students. (First three training class sessions meet 6:00 – 9:00 P.M.)

7 Advanced Legal Writing is limited to 20 students.

8 Elder Law and Small Claims Advisory Clinics are limited to 8 students.

9 Clinical Education is available to 3rd- and 4th-year students only.

10 Legal Aid Clinic - (option to take for 2 or 3 units)

11 Professional Responsibility is limited to 25 students and requires completion of 2nd year classes.

12 Community Property is limited to 25 students and requires completion of 2nd year classes and Real Property preferred

13 Criminal Procedure class limited to 30 students, priority given to 3rd- and 4th-year students.

14 Immigration Law Clinic is limited to 15 students.
